Social media misuse outside of school

In the Autumn term we reported that we had seen an increase of young people experiencing communication issues with each other outside of the school day and that unfortunately these sometimes carried on into the school day and created a barrier to their learning.

Whilst we will continue to address these issues in school with the young people, alongside their RSHE and e-safety lessons and we have also been telephoning parents and asking for your support in putting measures in place at home. The mobile phone app 'WhatsApp' is frequently the most reported mode of communication that is being reported the young people are using and where issues are arising.

"WhatsApp is available on smartphone and through WhatsApp Web. Users must be 16 or older in the UK, which will reduce to 13 Years old or older in April 2024 (for existing users). If a child signs up from 16 February 2024, they must be 13 Years old or older.

WhatsApp's privacy settings allow you to restrict who can see your child's messages and location. There are also ways to block delete or report users on the platform to promote internet safety and risk management.

Bullying

Learning to understand and manage conflict is an important part of growing up.

Bullying is not simply a 'falling out' with friends. Research shows that experiencing bullying can have a significant impact on a child's life well into adulthood. To ensure we are able to prevent bullying, act quickly when it takes place and avoid misidentifying bullying, it is vital that we have a shared definition of bullying.

At Fairmead School we define bullying as 'The repetitive, intentional hurting of one person or group by another person or group, where the relationship involves an imbalance of power. Bullying can be physical, verbal or psychological. It can happen face-to-face or online'.

Bullying behaviour can be:

Physical – pushing, poking, kicking, hitting, biting, pinching etc.

Verbal - name calling, sarcasm, spreading rumours, threats, teasing, belittling.

Emotional – isolating others, tormenting, hiding books, threatening gestures, ridicule, humiliation, intimidating, excluding, manipulation and coercion.

Sexual – unwanted physical contact, inappropriate touching, abusive comments, homophobic abuse, exposure to inappropriate films etc.

Online /cyber — posting on social media, sharing photos, sending nasty text messages, social exclusion Indirect - Can include the exploitation of individuals.

Please encourage your young person to talk to an adult and or report this to any staff at the school immediately. Please see our Behaviour Policy and Anti-Bullying Policy for more details.
